

RULES AND REGULATION

SOUTH TEXAS HEREFORD ASSOCIATION BULL SALE

1. Consignors selling bulls for the first time will be limited to 3 bulls.
2. All bulls must be bred by consignor, or purchased in dam, with the exception of one purchased bull.
3. Entry forms and registration papers are due by August 31, 2024.
4. Any consignments made after the deadline will be required to pay a late entry fee of \$100.00 per bull consigned.
- **ALL BULLS 12 MONTHS OF AGE OR OLDER MUST BE TRICHOMONIASIS TESTED REGARDLESS OF VIRGIN STATUS.**
5. Hereford Bulls shall be registered and clean pedigreed through six generations with American Hereford Assn., or clean pedigreed by progeny testing through American Hereford Association.
6. Bulls will not exceed the age of 39 months. Brahman bulls must be a minimum of 18 months old.
7. We will be selling ONLY 5 Brahman bulls in the sale.
8. A \$100.00 fee will be assessed to the consignor on any bull that is withdrawn from the sale after August 31, 2024.
9. Bulls must be in sale barn no later than 4:00 P.M. on Thursday, October 24, 2024.
10. If bull or bulls are withdrawn prior to or during the sale, the consignor must notify the secretary and scratch the bull and initial on master sale order to be posted in a convenient place in barn.
11. Bulls which are sold private treaty on premises will be charged regular commission and the money and transfers will be handled by the association just as if the bull had been sold in the ring.
12. Commission: A 7% commission will be charged for all bulls sold. A PO fee of \$100.00 will be charged to any bull not sold. The consignor will also be required to pay for liability cattle insurance that is provided for each animal that is at the sale facility. The fee will be based upon the last bid that is taken on the animal. The last bid is recorded immediately after the animal exits the sale ring. The percentage to cover the insurance is \$.50 per \$100.00. Example if you PO your bull at \$2500.00 the coverage will cost \$12.50.
13. **If you place a floor price on your bull, and sale management is not made aware of your PO price or you do not PO the bull yourself and it sells through the ring to a buyer, that sale is final.**
14. Payment for cattle sold will be mailed no sooner than 8 business days following the sale.

15. Certificate of Veterinary Inspections (health papers), breeding soundness form, and the original registration papers must be presented when the bull arrives at the sale facility. No cattle will be unloaded if health papers do not accompany the cattle. Lot numbers must be on the health papers. All bulls must have a white or yellow ear tag in either ear with the lot number. Bulls without lot number tags will be charged \$15 per bull and an ear tag will be put in the ear.
